# **Course Description**

AP® U.S. History is a challenging course that is meant to be the equivalent of a freshman college course and can earn students college credit. It is a twosemester survey of American history from the Pre-Columbian period to the present. Solid reading and writing skills, along with a willingness to devote considerable time to homework and study, are necessary to succeed. Emphasis is placed on critical and evaluative thinking skills, essay writing, interpretation of original documents, and historiography. The class is taught in accordance with the AP U.S. History curriculum framework, and is designed to prepare students for the AP U.S. History Exam in May.

#### Students will:

- ·master a broad body of historical knowledge
- ·demonstrate an understanding of historical chronology
- ·use historical data to support an argument or position
- ·differentiate between historiographical schools of thought
- •examine how political institutions, social and cultural developments, diplomacy, and economic trends are interweaved throughout history
- interpret and apply data from original documents, including cartoons, graphs, letters, etc.
- •effectively use analytical skills of evaluation, cause and effect, compare and contrast
- work effectively with others to produce products and solve problems
- •prepare for and successfully pass the AP U.S. History Exam

#### 1. What is your grading scale?

#### APUSH Exam Details\*

#### Section 1:

Part A - Multiple Choice Questions - 55 questions in 55 mins. This is 40% of your overall test grade.

- Questions appear in sets of 2 to 5.
- You'll be asked to analyze historical texts, interpretations, and evidence.
- Primary and secondary sources, images, graphs, and maps are included.

Part B - Short Answer Questions - 3 questions in 40 mins. This is 20% of your overall test grade.

- Analyze historians' interpretations, historical sources, and propositions about history.
- Questions provide opportunities for you to demonstrate what you know best.
- Some questions include texts, images, graphs, or maps. You'll have a choice between two options for the final required short- answer question, each one focusing on a different time period.
  - ~Question 1 (required): periods 3-8
  - ~Question 2 (required): periods 3-8
  - ~Choose between Question 3, periods 1-5, and Question 4, periods 6-9

#### Section 2:

Part A - Document Based Question - 1 question in 60 mins. (15 mins is a suggested planning time). This is 25% of your overall test

- Assess written, quantitative, or visual materials as historical evidence.
- · Develop an argument supported by an analysis of historical evidence.
- The document-based question will focus on topics from periods 3-8.

Part B - Long Essay - 1 question in 40 mins. This is 15% of your overall test grade.

- Explain and analyze significant issues in U.S. history.
- Develop an argument supported by an analysis of historical evidence.
- You'll select from one of three essay choices, each focusing on the same theme and skill but different time periods:
  - ~Option 1: period 1-3
  - ~Option 2: periods 4-6
  - ~Option 3: periods 7-9

\*It is mandotary for all APUSH students to sit for the entire AP Exam in May. They will earn a test grade of 100% for doing this.
